

Zilch Promotion Terms and Conditions

Zilch – “Clean Sheet Scarf Giveaway”

These Terms and Conditions set out the basis on which you can participate in the Zilch Clean Sheet Scarf Giveaway (the “Promotion”), brought to you by Zilch Technology Limited (“Zilch” or the “Promoter”). By participating in the Promotion, you agree to be bound by these Terms and Conditions. If you do not agree, you should not take part and you will not be eligible to win a Prize.

1. Promoter

The promoter of this Promotion is Zilch Technology Limited, a company registered in England and Wales (the “Promoter”).

2. Promotion Name

“Zilch Clean Sheet Scarf Giveaway” (the “Promotion”).

3. Promotion Period

3.1. The Promotion will run for the duration of the international men’s football tournament starting on 11 June 2026 and ending 19 July 2026 (the “Promotion Period”).

3.2. Each giveaway event will open at the final whistle of the relevant match and will close once all available Prizes for that match have been successfully redeemed.

4. Eligibility

4.1. The Promotion is open to UK residents aged 18 or over.

4.2. Employees of the Promoter, or anyone professionally connected with the Promotion, and their immediate families, are not eligible to participate.

4.3. No purchase is necessary to take part in the Promotion but you will require email and internet access to enter the Promotion. No refund may be claimed for any expenses incurred relating to the use of an email account or internet connection for the purpose of entering the Promotion.

4.4 For the purposes of this Promotion, a Clean Sheet means a match in which the England Men’s Football First Team does not concede any goals to the opposing team during the full duration of the match, including all regulation playing time (90 minutes) and any stoppage or added time awarded by the match officials. A Clean Sheet shall be determined based on the official match result at the final whistle and shall not include extra time or penalty shoot-outs unless expressly stated otherwise by the Promoter.

5. How to Participate

5.1. Following a qualifying clean sheet by England Men's Football first team, up to 1000 (one thousand) England Scarves ("Prizes") will be made available for redemption.

5.2. To participate, eligible individuals must visit <http://zilch.com/englandcleansheets> once the giveaway has opened and complete the online form for redemption as instructed.

5.3. If all available Prizes for a giveaway event have been redeemed, the online redemption form will no longer be available and individuals will be directed to a page confirming that the giveaway has closed. Where an individual is not able to submit a valid redemption, Zilch will not collect the name, email address or delivery address requested in the redemption form for the purposes of Prize fulfilment.

5.4. A redemption is only complete once the participant has submitted the online form and received confirmation that their redemption has been accepted.

5.5. Prizes will be allocated strictly on a first-come, first-served basis.

5.6. Only the first 1000 valid redemptions per qualifying match will receive a Prize.

6. Prize Details

6.1. The prize is one (1) England Scarf per successful claimant.

6.2. A maximum of one Prize may be claimed per household during the Promotional Period.

6.3. Prizes are non-transferable, non-exchangeable, and no cash alternative is available.

6.4. If the Prize is found to be defective upon receipt, the Promoter may, at its discretion, provide a replacement Prize or substitute the Prize with an item of equal or greater value if necessary. This is the sole remedy available to the winner in relation to any defect, and no cash alternative will be offered.

6.5. The Promoter will determine, in its sole discretion, whether a Qualifying Clean Sheet has been achieved

6.6. The Promoter will only deliver Prizes to addresses within the United Kingdom.

7. Delivery

7.1. Prizes will be delivered to the UK postal address provided during redemption.

7.2. Postage and packaging within the United Kingdom is free of charge.

7.3. Unless otherwise notified to the winner, each Prize will be shipped via UK standard delivery to the winners within 30 days of confirmation of the winner's address for delivery of the Prize.

7.4. The Promoter accepts no responsibility for incomplete or incorrect address details provided by participants.

8. Fair Use and Abuse

8.1. The Promoter reserves the right to disqualify any participant who attempts to manipulate, abuse, or undermine the fair operation of the Promotion, including but not limited to automated entries, false information, or fraudulent behaviour. Any such entries will be deemed invalid.

8.2. Zilch may use the details submitted through the redemption form, including name, email address and delivery address, to verify valid redemptions, enforce the one Prize per person limit, prevent automated, duplicate, fraudulent or abusive entries, administer the Promotion and manage Prize delivery queries. These checks will be limited to what is necessary for the fair and secure operation of the Promotion.

9. Changes or Cancellation

The Promoter reserves the right to amend, suspend, or cancel the Promotion at any time due to circumstances beyond its reasonable control, or where required for legal, regulatory, or operational reasons. Any such changes will not affect valid redemptions already completed.

10. Limitation of Liability

To the maximum extent permitted by law, the Promoter will not be liable for any loss or damage arising out of or in connection with the Promotion, including but not limited to:

- Website downtime or technical failures
- Delayed or failed redemptions
- Lost, delayed, or damaged deliveries

11. Governing Law and Jurisdiction

These Terms and Conditions are governed by English law. Any disputes arising in connection with the Promotion shall be subject to the non-exclusive jurisdiction of the courts of England and Wales.
